
Sub :- Online filing of Immovable Property Return (IPR)-reg.

CIRCULAR:

With reference to the subject cited above, all IPS officers are requested to file their Immovable Property Return (IPR) in prescribed form every year on or before 31st January of the subsequent year through SPARROW Portal / Application. Further, vide notification dated 30/12/2021, Rule 3 (1) of IPS (Pay) Rules, 2016 has been amended to make timely filing of IPR mandatory for being considered for appointment to the next pay level of pay matrix.

2. In case the officer fails to submit the IPR (online) within the stipulated time limit, his / her vigilance clearance will be denied in terms of DoPT OM No.104/76/2022-AVD.IA, dated 28/09/2022.

3. D.O.letter dated 15.07.2025 received from Govt. of India, New Delhi is available on Maharashtra Police website. In case of any difficulty in accessing IPR module through SPARROW, the officer can send their grievances through e-mail at support-sparrow@nic.in or sparrow.ips@nic.in.

As you are aware that the Rule 16(2) of AIS(Conduct)Rules, 1968 prescribes that every member of IPS is required to submit their Immovable Property Return (IPR) in prescribed form every year on or before 31st January of the subsequent year through SPARROW Portal /Application. Further, vide notification dated 30.12.2021, Rule 3(1) of IPS (Pay) Rules, 2016 has been amended to make timely filing of IPR mandatory for being considered for appointment to the next pay level of pay matrix.

In this connection, it has been noted that some of the IPS officers of your State/Cadre have so far not filed/late filed their IPR for the year 2024 (Annexure-'A').

I would like to request you to kindly issue necessary instruction to all IPS officers of your cadre for timely filing of IPR and also to sensitize them about serious complications of late/non filing of IPR.
