केंद्र शासनाकडून स्वतःच्या जीवाची पर्वा न करता मानवतेच्या दृष्टीकोनातून केलेल्या कामाबद्दल जीवन रक्षा पदक प्रदान करण्यात येते, यामध्ये पाण्यात बुडण्याच्या घटना, अपघात, आगीच्या घटना, विद्युत शॉर्ट सर्किटने घडणाऱ्या घटना, भुकंप, दरड कोसळणे, रानटी जनावराने केलेला हल्ला व खाणीमध्ये केलेले बचावकार्य इत्यादीमध्ये स्वतःच्या जीवाची पर्वा न करता जीव वाचवितांना दाखविलेल्या शौर्यपूर्ण कामगिरी करणाऱ्या व्यक्तीस दिला जातो.

केंद्र शासनाने त्यांचे पत्र क्र. १७/३/२०२६-पब्लीक, दिनांक ३०/०३/२०२६ अन्वये दिनांक १ ऑक्टोबर, २०२४ नंतर घडलेल्या घटनांसाठी जीवन रक्षा पदक-२०२६ प्रदान करण्यात येणार आहे. त्याकरीता महाराष्ट्र पोलीस दलातील पोलीस अधिकारी व अंमलदार यांच्या शिफारशी मागविल्या आहेत. सोबत केंद्र शासनाचे पत्र सहपत्रासह जोडले आहे.

जीवन रक्षा पदक हे खालील ३ प्रवर्गासाठी दिले जातात.

- १) सर्वोत्तम जीवन रक्षा पदक - अत्यंत धोकादायक परिस्थितीमध्ये एखाद्या व्यक्तीचा जीव वाचवितांना बचावकार्य करणाऱ्या व्यक्तीच्या जीवाला आत्यंतिक धोका पोहोचला असेल, अशावेळी अतुलनीय शौर्याचे प्रदर्शन करणाऱ्या व्यक्तींना पदक प्रदान करण्यात येते.
- २) उत्तम जीवन रक्षा पदक - अत्यंत धोकादायक परिस्थितीमध्ये स्वतःचा जीव धोक्यात टाकून एखाद्या व्यक्तीचा जीव वाचवितांना दाखविलेले धैर्य व तत्परता दाखवून जीव वाचवणाऱ्या व्यक्तीला सदरचे पदक प्रदान करण्यात येते.
- ३) जीवन रक्षा पदक - एखाद्या व्यक्तीचा जीव वाचवितांना बचाव कार्य करणाऱ्या व्यक्तीला गंभीर दुखापत होण्याच्या परिस्थितीत धैर्य व तत्परता दाखवून जीव वाचवणाऱ्या व्यक्तीला सदरचे पदक प्रदान करण्यात येते.

तरी, खालील सर्व घटक प्रमुख यांना विनंती करण्यात येते की, त्यांनी जीवन रक्षा पदकासाठी आवश्यक अटी व शर्ती पूर्ण करणाऱ्या पोलीस अधिकारी व अंमलदार यांचे विहित नमुन्यातील प्रस्ताव व प्रमाणपत्र दिनांक ३१/०७/२०२६ पर्यंत या कार्यालयास सादर करावेत.

Sub: Recommendations for Jeevan Raksha Padak Series of Awards-2026.

Sir/Madam,

Jeevan Raksha Padak series of awards are given for meritorious acts of humane nature in saving the life of a person in incidents like drowning, accidents, fire incidents, electrocution, landslides, animal attack and rescue operation in mines etc. As the name of the award suggests, **the award is given to a rescuer for saving someone's life.** It is given in the following three categories: -

- i) **Sarvottam Jeevan Raksha Padak** - awarded for conspicuous courage in saving life under circumstances of very great danger to the life of the rescuer.
- ii) **Uttam Jeevan Raksha Padak** - awarded for courage and promptitude in saving life under circumstances of great danger to the life of the rescuer.
- iii) **Jeevan Raksha Padak** - awarded for courage and promptitude in saving life under circumstances of grave bodily injury to the rescuer.

2. Persons in all walks of life are eligible for these awards. Members of the Armed Forces, Police Forces and of recognized Fire Service etc. are also eligible for these awards provided the life saving act is performed by them. **As the Prime Minister's Police Medal for Life Saving" instituted by Ministry of Home Affairs has been subsumed in the "Jeevan Raksha Padak", the members of CAPFs/CPOs and Police Forces, who have shown exemplary devotion to duty in saving human life, are also eligible for Jeevan Raksha Padak.** The award is also conferred posthumously.

3. Every year, the Ministry of Home Affairs invites recommendations from all State Governments/UT Administrations, Ministries/Departments of the Government of India, CAPF and other authorities for these awards. The recommendations are examined by a high-level Awards Committee, which makes its recommendations to the Prime Minister and the President. After approval of the President, the decoration of the award, i.e., Medal and Certificate along with the monetary allowance in respect of the awardees, are sent to the concerned recommending authorities.

4. Over the last few years, it has been observed that various acts of life saving by individuals during natural calamities, accidents, extremists attack, drowning/fire incidents etc. are reported in the print and electronic media. However, such valiant and gallant acts go unrecognized in the absence of suitable nominations by the State/UT Government and authorities under whose jurisdiction such acts take place. You would appreciate that awards and decorations are tangible tokens of recognition of the services rendered by an individual. Such awards encourage and motivate others for similar action in the hour of need. The concerned authorities are, therefore, requested to send suitable and deserving nominations to this Ministry for consideration. It may be noted that the recommendations for this award are considered by Awards Committee within a period of two years from the date of performance of the gallant act. **Therefore, for the year 2026, any recommendation in respect of which the date of performance of the life saving act falls prior to 1st October 2024 should not be forwarded to this Ministry for consideration.**

5. **The recommendations for the Jeevan Raksha Padak series of Awards can be sent in online mode only through the password protected Rashtriya Puraskaar Portal designed by the Ministry of Home Affairs, (URL: <https://www.awards.gov.in>).** The recommendations should contain all relevant details specified in the format available on the above said portal, including a citation in narrative form (maximum 250 words), clearly bringing out the sequence-wise details of the incident, courage and promptitude displayed by the rescuer and danger to life and also specific role/contribution of the person (rescuer).

6. A character and antecedent verification certificate duly signed and stamped by the recommending authority may be scanned and uploaded on the portal. A Performa of this certificate is available on website. A copy of above is enclosed with this letter. While recommending a person online, it may be ensured that all the necessary details including name of the recommended person in Hindi are filled properly.


